Accessibility Plan 2020-2023

Beck Row Primary Academy has been described as having a 'welcoming and delightfully happyenvironment in which pupils thrive and want to do their best.' We want all children to enjoy school, to be challenged to achieve their very best, and to consider their time at the school as their own 'learning adventure'. We are committed to giving all of our children every opportunity to achieve the highest of standards. We do this by taking account of pupils' varied life experiences and needs. We offer a broad and balanced curriculum and have high expectations for all children. The achievements, attitudes and well-being of all our children matter.

Purpose of Plan

This plan shows how Beck Row Primary Academy intends, overtime, to increase the accessibility of our school for disabled pupils, staff, parents/carers and visitors.

Definition of disability

A person has a disability if he/she has a physical or mental impairment that has a substantial and long-term adverse effect on his/her ability to carry out normal day- to-day activities.

Areas of planning responsibilities

- Increasing access for disabled pupils to the school curriculum (this includes teaching and learning and the wider curriculum of the school such as participation in after-school clubs, leisure and cultural activities or school visits)
- Improving access to the physical environment of schools (this includes improvements to the physical environment of the school and physical aids to access education)
- Improving the delivery of written information to disabled pupils (this will include planning to make written information that is normally provided by the school to its pupils available to disabled pupils. The information should takeaccount of pupils' disabilities and pupils' and parents' preferred formats and be made available within a reasonable timeframe





Contextual Information

Beck Row Primary Academy is located in West Suffolk. The school currently has 11 in use classrooms, a library/meeting room, accessible disabled toilets and a large outdoor area. The reception is the first part of the school upon arrival and entrance points for the school are; by a gate next to reception for Year 6 and EYFS, directly into the classroom for Year 1 classes, then through a side entrance and into the heart of the school for year 2 to 5 inclusive. Wheelchair access is through all areas of the school. We currently have 1 student with need for wheelchair access and mobility frame access, which is catered for.

Current Range of known disabilities

The school has children with a range of disabilities to include moderate and specific learning disabilities, including Autism, Global Developmental Delay, ADHD, Cerebral Palsy, with a wide array of others.

We also have students with hearing impairments and physical disabilities and injuries.

Increasing access for disabled pupils to the school curriculum.

Improving teaching and learning lies at the heart of the school's work. Through selfreview and Continuous Professional Development (CPD), we aim to enhance staff knowledge, skills and understanding to promote excellent teaching and learning for all children. We aim to meet every child's needs within mixed ability, inclusive classes.

It is a core value of the school that all children are enabled to participate fully in the broader life of the school. Consequently, all children have always been permitted to attend age relevant after school clubs, leisure and cultural activities and educational visits. The only exception would occur if a child had breached school rules when deprivation of club attendance may be used as a suitable short-term sanction and to ensure the safety of others.

Improving the delivery of written information to disabled pupils

This will include planning to make written information that is normally provided by the school to its pupils available to disabled pupils. Examples might include handouts, textbooks and information about school events. The information should take account of pupils' disabilities and pupils' and parents' preferred formats and be made available within a reasonable timeframe.

In planning to make written information available to disabled pupils we again need to establish the current level of need and be able to respond to changes in the range of need. The school will need to identify agencies and sources of such materials to be able to make the provision when required. The schools ICT infrastructure will enable us to access a range of materials supportive to need.
