Data Controller

Barnham Primary School complies with the General Data Protection Regulations (GDPR) and the Data Protection Act (DPA) and is registered as a 'Data Controller' with the Information Commissioner's Office and the schools registration number is ZA127855.

The Data Protection Officer (DPO) for the School is Nicky Schofield.

We ensure that your personal data is processed fairly and lawfully, is accurate, is kept secure and is retained for no longer than is necessary.

The Legal Basis for Processing Personal Data

The main reason that the school processes personal data is because it is necessary in order to comply with the school's legal obligations and to enable it to perform tasks carried out in the public interest,

The school may also process personal data if at least one of the following applies:

- in order to protect the vital interests of an individual
- there is explicit consent
- to comply with the school's legal obligations in the field of employment and social security and social protection law
- for the establishment, exercise or defense of legal claims or whenever courts are acting in their judicial capacity
- for reasons of public interest in the area of public health
- for the purposes of preventive or occupational medicine, for the assessment of the working capacity of
 the employee, medical diagnosis, the provision of health or social care or treatment or the
 management of health or social care systems and services, based on law, or pursuant to contract with
 a health professional
- for reasons of substantial public interest, based on law, which is proportionate in the circumstances
 and which has provided measures to safeguard the fundamental rights and the interests of the data
 subject;
- For data collection purposes Education Act 1996 departmental censuses

The categories of school workforce information that we collect, process, hold and share include:

- personal information (such as name, employee or teacher number, national insurance number, contact details, including address, phone numbers and email address, marital status)
- special categories of data including characteristics information such as gender, age, ethnic group

- contract information (such as start dates, hours worked, post, roles and salary information)
- work absence information (such as number of absences and reasons)
- performance (such as capability and disciplinary matters)
- qualifications and recruitment information (and, where relevant, subjects taught)
- information relevant to the School Work Force Census and absence information
- payroll information bank details, student loans, union memberships, annual pay information
- relevant medical and allergy information
- Emergency contact details including next of kin.

Why we collect and use staff information

We process personal data relating to those we employ to work at, or otherwise engage to work at our School for:

- employment purposes,
- enable the development of a comprehensive picture of the workforce and how it is deployed
- inform the development of recruitment and retention policies
- to assist in the running of the School
- to enable individuals to be paid.

The collection of this information will benefit both national and local users by:

- improving the management of workforce data across the sector
- enabling development of a comprehensive picture of the workforce and how it is deployed
- informing the development of recruitment and retention policies
- allowing better financial modelling and planning
- enabling ethnicity and disability monitoring; and
- supporting the work of the School Teachers' Review Body
- protecting vulnerable individuals;
- the prevention and detection of crime

Whilst the majority of information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with data protection legislation, we will inform you whether you are required to provide certain school workforce information to us or if you have a choice in this.

Who we share this information with

We will not give information about you to anyone outside the School without your consent unless the law allow us to.

We routinely share this information with:

- our local authority
- the Department for Education (DfE)
- our payroll provider
- our absence insurer
- our occupational health provider

We do not share information about workforce members with anyone without consent unless the law and our policies allow us to do so.

Local authority

We are required to share information about our workforce members with our local authority (LA) under section 5 of the Education (Supply of Information about the School Workforce) (England) Regulations 2007 and amendments.

Department for Education (DfE)

We share personal data with the Department for Education (DfE) on a statutory basis. This data sharing underpins workforce policy monitoring, evaluation, and links to school funding / expenditure and the assessment educational attainment.

We are required to share information about our pupils with the (DfE) under section 5 of the Education (Supply of Information about the School Workforce) (England) Regulations 2007 and amendments.

Payroll Provider

We share personal data with our payroll provider to enable staff to be paid and statutory deductions to be made.

Absence Insurer

We share personal data with our provider of absence insurance to ensure that the school has adequate insurance cover in place to meet with need of the staff team and operational requirements of the school.

Occupational Health Provider

Where necessary personal details are shared with our Occupational Health Provider to provide them will the relevant information to undertake occupational assessments.

Data collection requirements

The DfE collects and processes personal data relating to those employed by schools (including Multi Academy Trusts) and local authorities that work in state funded schools (including all maintained schools, all academies and free schools and all special schools including Pupil Referral Units and Alternative Provision). All state funded schools are required to make a census submission because it is a statutory return under sections 113 and 114 of the Education Act 2005

Complaints to ICO
