## **Introduction and Background**

Barnham Primary School recognises that positive behaviour and good attendance are essential in order to raise standards of pupil attainment and to give every child the best educational experience possible.

The law entitles every child of compulsory school age to an efficient, full-time education suitable to their age, aptitude, and any special educational need they may have. It is the legal responsibility of every parent to make sure their child receives that education either by attendance at a school or by education otherwise than at a school.

Where parents decide to have their child registered at school, they have an additional legal duty to ensure their child attends that school regularly. This means their child must attend every day that the school is open, except in a small number of allowable circumstances such as being too ill to attend or being given permission for an absence in advance from the school.

The DfE has produced guidance for maintained schools, academies, independent schools, and local authorities: Working together to improve school attendance and Mental Health issues affecting a pupil's attendance: guidance for schools. Our Attendance Policy reflects the key principles of this guidance.

This policy is written with the above guidance in mind and underpins our school ethos to:

- promote children's welfare and safeguarding
- ensure every pupil has access to the full-time education to which they are entitled
- ensure that pupils have the opportunity to succeed whilst at school
- ensure that pupils have access to a wide range of opportunities at school

The policy seeks to ensure that all parties involved in the practicalities of school attendance are aware and informed of attendance matters in school and to outline the school's commitment to attendance matters. It details the responsibilities of individuals and groups involved and the procedures in place to promote and monitor pupil attendance.

Our policy aims to raise and maintain levels of attendance by:

- Promoting a positive and welcoming atmosphere in which pupils feel safe, secure and valued
- Raising awareness of the importance of good attendance and punctuality
- Ensuring that attendance is monitored effectively and reasons for absences are recorded promptly and consistently

For our children to gain the greatest benefit from their education it is vital that they attend regularly and be at school, on time, every day the school is open unless the reason for the absence is unavoidable. **It is a rule of this school that pupils must attend every day, unless there are exceptional circumstances and it is the *headteacher*, not the parent, who can authorise the absence.**





## Promoting Regular Attendance

At Barnham Primary School, we believe in developing good patterns of attendance and set high expectations for the attendance and punctuality for all our pupils from the outset. It is a central part of our school's vision, values, ethos, and day to day life. We recognise the connections between attendance, attainment, safeguarding and wellbeing.

Helping to create a pattern of regular attendance is the responsibility of parents, pupils and all members of school staff.

To help us all to focus on this we will:

- Report to parents/carers regularly on their child's attendance
- Give parents/carers updates and reminders on attendance in our newsletters
- Contact parents/carers should their child's attendance have an identified pattern of absence or falls below the school's expected level for attendance
- Support parents/ carers to help them with attendance or issues with punctuality
- Inform the relevant agencies and seek support from school agency partners when required

## Understanding Types of Absence

Any absence affects the pattern of a child's schooling and regular absence will seriously affect their learning. Any pupil's absence or late arrival disrupts teaching routines and so may affect the learning of others in the same class. Ensuring a child's regular attendance at school is a parental responsibility and allowing absence from school without a good reason creates an offence in law and may result in prosecution.

Every half-day absence from school has to be classified by the school (not by the parent), as either **authorised** or **unauthorised**. This is why information about the cause of any absence is always required. Each half-day is known as a 'session'.

**Authorised absences** are morning or afternoon sessions away from school for a genuine reason such as illness, medical or dental appointments which unavoidably fall in school time, emergencies or other unavoidable cause.

**Unauthorised absences** are those which the school does not consider reasonable and for which no 'leave' has been granted. This type of absence can lead to the school referring to the Local Authority for penalty notices and/or legal proceedings.

Unauthorised absence includes, however is not exhaustive:

- parents/carers keeping children off school unnecessarily e.g. because they had a late night or for non-infectious illness or injury that would not affect their ability to learn





- absences which have never been properly explained
- children who arrive at school after the close of registration are marked using a 'U'. This indicates that they are in school for safeguarding purposes, however is counted as an absence for the session
- shopping trips
- looking after other children or children accompanying siblings or parents to medical appointments
- their own or family birthdays
- holidays taken during term time without leave, not deemed 'for exceptional purposes' by the headteacher - may result in school applying to the local authority to issue a penalty notice or if you have previously been issued a Penalty Notice, the school may request a direct prosecution by the local authority
- day trips
- other leave of absence in term time which has not been agreed

### **Persistent Absenteeism (PA)**

A pupil is defined by the Government as a '**persistent absentee**' when they miss 10% or more schooling across the school year for any reason; this can be authorised or unauthorised absence. Absence at this level can cause considerable damage to any pupil's education.

### **Absence Procedures**

We monitor all absence, and the reasons that are given, thoroughly.

### **If a child is absent from school the parent must follow these procedures:**

- Contact the school on the first day of absence before **9.00 am**. The school has an answer phone available to leave a message if nobody is available to take your call, or you may call into school personally and speak to the office staff. You can also email the school using [office@barnhamprimaryschool.co.uk](mailto:office@barnhamprimaryschool.co.uk)
- Contact the school on every further day of absence, again before **9.00 am**.
- Ensure that your child returns to school as soon as possible.

### **If your child is absent we will:**

- Telephone or text you on the first, and every subsequent day of absence, if we have not heard from you however it is your responsibility to contact us
- If we are unable to contact parents by telephone, we will telephone emergency contact numbers, email and a home visit may be made in the interests of safeguarding
- As a school we follow the WSCC policy for 'Children Missing in Education', and will implement this policy as required and when triggered by concerns for the child's safety and well being (see [WSCC Schools Safeguarding Handbook for policy](#))





### **If absence continues we will:**

- Write or speak to you face-to-face to you if your child's attendance is below 95% and there are no reasonable or known reasons for this absence.
- Invite you into school to discuss the situation if absences persist.
- Create a personalised action/support plan to address any barriers to attendance
- Offer signposting support to other agencies or services if appropriate
- Refer the matter to the Local Authority for relevant sanctions if attendance deteriorates following the above actions

### **Lateness**

Poor punctuality negatively impacts everyone. and can contribute to further absence. Good time-keeping is a vital life skill which will help children as they progress through their school life and out into the wider world.

Pupils who arrive late disrupt lessons and, if a child misses the start of the day, they can feel unsettled and embarrassed, miss vital work and important messages from their class teacher.

### **The times of the start and close of the school day for all pupils at Barnham Primary School Primary are:**

Gates open: 8.40 am

School day starts: 8:50am

Registration closes: 9:00am

End of the school day: 3.20 pm

Gates close: 3.30pm

### **How we manage lateness:**

- Registers are taken at **9:00am** and your child will receive a late mark 'L' if they are not in by that time
- Children arriving after **9.00am** are required to come into school via the school office. If accompanied by a parent/carer they must sign in and provide a reason for their lateness which is recorded
- At **9.30am** the registers will be closed. In accordance with the Regulations, if your child arrives after that time, they will receive a mark that shows them to be on site - 'U', but this will **not** count as a present mark and it will mean they have an unauthorised absence
- The school may contact parents/carers regarding lateness

Unauthorised lateness could result in the school referring to the Local Authority for sanctions and/or legal proceedings. If your child has a persistent late record, you will be asked to meet with a senior leader but you can approach us at any time if you are having difficulties getting your child to school on time. We expect parents and staff to encourage good punctuality by being good role models to our children and celebrate good class and individual punctuality.

### **Understanding barriers to attendance**

Whilst any child may occasionally have time off school because they are too unwell to attend, sometimes they can be reluctant to attend school. Any barriers preventing regular attendance are best resolved between the school, the parents and the child. If a parent thinks their child is reluctant to attend school, then we will work with that family to understand the root problem and provide any necessary support. We can use outside agencies to help with this, such as the School Nurse, Mental Health and Emotional Wellbeing support services, a Child and Family Support Worker or the relevant Local Authority team/s.





Where outside agencies are supporting the family, you may be invited to attend a Team Around the Family meeting (TAF) to consider what is working well and what needs to improve. An individualised early help plan will be agreed and subsequently reviewed.

Some pupils face greater barriers to attendance than their peers. These can include pupils who suffer from long-term medical conditions or who have special educational needs and disabilities, or other vulnerabilities. High expectations of attendance remain however, we will work with families and pupils to support improved attendance whilst being mindful of the additional barriers faced. We can discuss reasonable adjustments and additional support from external partners where appropriate.

Parents are expected to contact school at an early stage and to work with the staff in resolving any problems together. This is nearly always successful.

If difficulties cannot be sorted out in this way, the school may refer the child to the Local Authority. Local Authority Attendance Specialists work with schools, families and other professionals to reduce persistent absence and improve overall attendance.

If attendance does not improve, legal action may be taken in the form of a Penalty Notice, prosecution in the Magistrates Court or the application of an Education Supervision Order, designed to strengthen parental responsibilities and ensure improved attendance.

### **Local Authority attendance support services**

Local Authority Attendance Specialists work strategically by offering support to schools, families, and other professionals to reduce persistent absence and improve overall attendance.

Parents are expected to work with the school and local authority to address any attendance concerns. Parents should proactively engage with the support offered, aiming to resolve any problems together. This is nearly always successful. If difficulties cannot be resolved in this way, the school may consider more formal support and/or refer the child to the Local Authority. If attendance does not improve, legal action may be taken in the form of a Penalty Notice, prosecution in the Magistrates Court or the application of an Education Supervision Order, designed to strengthen parental responsibilities and ensure improved attendance.

### **School Attendance and the Law**

By law all children of compulsory school age must receive an appropriate full-time education (Education Act 1996). Parents have a legal duty to ensure their child attends school regularly at the school at which they are registered.

Parents may be recognised differently under education law, than under family law. Section 576 of the Education Act 1996 states that a 'parent', in relation to a child or young person, includes any person who is not a parent (from which can be inferred 'biological parent') but who has parental responsibility, or who has care of the child.





A person typically has care of a child or young person if they are the person with whom the child lives, either full or part time and who looks after the child, irrespective of what their biological or legal relationship is with the child.

Unauthorised absence may result in the school referring to the Local Authority for sanctions and/or legal proceedings. This may include issuing each parent with a Penalty Notice for £120, reduced to £60 if paid within 21 days or referring the matter to the Magistrates Court whereby each parent may receive a fine up to £2500 and/or up to 3 months in prison. If a parent is found guilty in court, they will receive a criminal conviction.

**There is no entitlement in law for pupils to take time off during the term to go on holiday.** In addition, the Supreme Court has ruled that the definition of regular school attendance is "in accordance with the rules prescribed by the school".

The Education (Pupil Registration) (England) Regulations 2006 were amended in September 2013. All references to family holidays and extended leave have been removed. The amendments specify that headteachers may not grant any leave of absence during term time unless there are "exceptional circumstances" and they no longer have any discretion to authorise up to ten days of absence each academic year.

It is a rule of this school that a leave of absence shall not be granted in term time unless there are reasons considered to be exceptional by the headteacher, irrespective of the child's overall attendance. Only the headteacher or his/her designate (not the local authority) may authorise such a request and all applications for a leave of absence must be made in writing on the prescribed form provided by the school. Where a parent removes a child when the application for leave was refused or where no application was made to the school, the issue of a penalty notice may be requested by this school.

A Penalty Notice may be issued where there have been at least 10 consecutive sessions of unauthorised absence for the purpose of a holiday, however, due to the importance of pupils settling into school at the commencement of the school year, Penalty Notices may also be issued if there have been at least 6 consecutive sessions of unauthorised absence during the first two calendar weeks of September due to a term-time holiday.

**At Barnham Primary School 'exceptional circumstances' will be interpreted as:**

... being of unique and significant emotional, educational or spiritual value to the child which outweighs the loss of teaching time (as determined by the headteacher). The fundamental principles for defining 'exceptional' are events that are "rare, significant, unavoidable and short". By 'unavoidable' we mean an event that could not reasonably be scheduled at another time, outside of school term time.

**We will not consider applications for leave during term time:**

- during assessment and test periods in the school's calendar affecting your child.
- when a pupil's attendance record already includes any level of unauthorised absence or they have already been granted authorised leave within that academic year.







If leave of absence is authorised, the school will not provide work for children to do during their absence. Parents are however advised to read with their children and encourage them to write a diary while they are away.

### **Children Missing in Education**

A registered pupil is deemed to be missing when:

- He or she fails to attend school without any explanation and;
- The school has been unable to establish the reason, or locate the pupil with any of the contact names at the last known address, or from intelligence from the wider school community; or
- The pupil's parents/carers have not provided any information to indicate a change of education provision, unavoidable cause for the pupil's absence or that the pupil is travelling with them whilst in pursuit of their business.

In such cases the school will make every effort to locate the child, should we be unsuccessful we may seek a we will request a Police Welfare check, contact social care and will refer the matter to the Local Authority (Children Missing in Education Team). Following which the Local Authority may advise that the pupil should be removed from roll.

### **Deletion from Roll**

For any pupil leaving Barnham Primary School, other than at the end of year 6, parents/carers email the school office and the school office will complete the West Sussex online School Roll Removal Notification. This information is essential to ensure that we know the whereabouts and appropriately safeguard all of our pupils, even those who leave us.

It is crucial that parents keep school updated with current addresses and contact details for key family members in case of emergency.

Under Pupil Regulations 2006, all schools are now **legally required** to notify their Local Authority of **every new entry** to the admission register **within five days** of the pupil being enrolled. In addition to this, **every deletion** from the school register must also be notified to the Local Authority, as soon as the ground for deletion has been met in relation to that pupil, and in any event no later than the time at which the pupil's name is deleted from the register. This duty does not apply when a pupil's name is removed from the admission register at a standard transition point – when the pupil has completed the final year of education normally provided by that school.

### **Absence data**

We use data to monitor, identify and support individual pupils or groups of pupils when their attendance needs to improve. Persistently absent pupils are tracked and monitored carefully. We also combine this with academic tracking as increased absence affects attainment.

### **Summary**

The school has a legal duty to publish its absence figures to parents and to promote attendance.

Equally, parents have a duty to make sure that their children attend school, on time, every day.

*All school staff and the Trustee Body are committed to working with parents/carers and pupils as this is the best way to ensure as high a level of attendance at our school as possible.*

### Role of Pupil Entitlement: Investigation

When a child is recorded as absent from school without authority their parent(s) can be held accountable for an offence under S.444 of the Education Act 1996.

When unauthorised absence occurs, the school has the option to refer it to the local authority to consider intervention, dependent on the length and the reason for the absence. This can be by one of two pathways:

A request for the use of a Fixed Penalty Notice (FPN)

A request for the allocation of an Investigating Officer.

Referrals are reviewed and acted upon by Pupil Entitlement: Investigation (PE:I), who finalise which pathway of intervention is to be taken.

All cases referred to PE:I are considered on an individual, case-by-case basis, reviewing the submission made by the school. PE:I must be satisfied that an offence under the Education Act 1996 has occurred and then decide the form of intervention to be instigated, if any.

Interventions can be allocation to an Investigating Officer and/or the use of a Fixed Penalty Notice.

### Role of the Investigating Officer

The Investigating Officer is tasked to ascertain whether the evidential requirements of the offence under the Education Act have been met. This is achieved by reviewing the submission from the school and by contacting the parent(s) and speaking to the child and other professionals. We encourage all parents to respond to our contact.

At the conclusion of the investigation a decision will be made as to the next steps which can include:

- the matter being referred to the Criminal Courts for non-attendance offences contrary to S.444 of the Education Act 1996
- the matter being referred to the Family Courts for the application of an Education Supervision Order - you can find information on ESOs on [GOV.UK](https://www.gov.uk) and by reading the supporting document below
- the case transferred to the FPN team
- the matter being closed.

## Fixed Penalty Notices

Fixed Penalty Notices (FPNs) are generally issued where there have been at least 10 sessions of unauthorised absence from school within a recorded 10 school week period. However, there are some occasions where they are issued outside of these criteria.

FPNs are issued per parent, per child and are an alternative to prosecution. This gives the parent an opportunity to discharge their criminal liability by paying a fine of £120, which must be paid within 28 days. If you pay the FPN within 21 days, the amount is reduced to £60.

When FPNs have not been paid within the 28 days we will consider prosecuting for the original non-attendance, not for the non-payment of the FPN. Further information on legal action that can be taken can be found on [GOV.UK](https://www.gov.uk). Alternatively, we may transfer the case to an [Investigating Officer](#). Please note: should the period of unauthorised absence for a holiday in term time be 15 school days or more, a FPN may not be deemed suitable. Instead the matter may be brought directly before the court.

### Paying a Fixed Penalty Notice

You can pay online using the reference number stated on the FPN. A unique reference number for each child will be provided.

You will need to select 'Fixed Penalty Notice - School attendance fine'.

If you pay the fine within 21 days it is reduced by 50 per cent to £60. Once over the 21 days the fine must be paid in full. Both these amounts can be selected on the payment form. If you are over the 21 days and only pay £60 we will contact you to request the outstanding amount.

Alternative methods of payment are outlined on the FPN.
